1. a new form of donation to support historical discoveries: the BGT Project

The history of humankind is a series of amazing discoveries. Remains of ancient civilizations, lost works of art, unknown natural phenomena - these discoveries have deepened our understanding of the past and provided insight into the future. Yet many of these important discoveries lie unrealized due to lack of adequate funding and support.

The sunken Titanic and the battleship Musashi, which drifted through the deep ocean currents undiscovered. If the project to investigate these things is left to the national government, it will never get underway. If each and every passionate individual around the world gathered together, we could have found them much sooner.

The BIG Treasure (BGT) project offers an innovative solution to this challenge. We have created a platform that allows people around the world to contribute to historical discoveries through a new donation mechanism that leverages blockchain technology.

Vision and mission of the project and platform

The BGT platform directly connects explorers who are passionate about historical discoveries with donors who understand their importance and want to support them. On this platform:

- Searchers can propose their own projects and raise the necessary funds
- Donors can donate directly to projects of interest and track their progress
- The entire community can participate in project selection and evaluation

The vision of the BGT project is to "decentralize and privatize historical discoveries, preserve cultural heritage, and enrich human knowledge". Our mission is as follows

1. facilitate funding for significant historical discoveries
2. provide a platform to directly connect searchers and donors
3. make the discovery process and results transparent and share them with all participants
4. build a global community through contributions to historical discovery

2. wisdom from history, contribution to the future: VOC model

The idea underlying the BGT project goes back more than 400 years to an innovative business model: the Dutch East India Company (VOC), founded in 1602, was the world's first known joint stock company. The VOC raised money from private investors, which it used to conduct large-scale overseas exploration and trade. VOC collected funds from private investors and used them to conduct large-scale overseas exploration and trade. This structure made it possible for ordinary citizens to participate in global adventures and share in the results.

New trade routes were discovered, profits from the pepper and tea trade were shared, and risks such as sinkings and shipwrecks were spread.

The point that the VOC model was innovative:

1. diversification of risk: If there is only one shipowner, the ship will be a total loss if it sinks or is attacked by pirates. If all co-participants share the risk, you will not suffer a total loss, and you will get it back the next time.

2. liquidity of funds: when you need funds on hand, you can choose to sell only 10% of the rights to the ship instead of selling the entire ship.

3. transparency: Even though the general public could participate in the VOC, the major shareholders were Her Majesty the Queen of England, aristocrats, and big merchants. As such, the captains of the business did not fail to report regularly to their investors, the powers that be.

BGT Project: Non-profit reinterpretation of VOC philosophy

The BGT project reinterprets the VOC model for the 21st century and applies it on a non-profit basis:

1. donation-based model: not for financial gain, but to uncover the wisdom of humanity and contribute to cultural heritage
2. global participation: open to everyone in the world, without geographical restrictions
3. diversity of projects: we support historical discoveries from all countries and disciplines, not just specific nations
4. public use of results: The results of discoveries are widely shared as common property of mankind

The BGT project was inspired by the innovative co-financing model of the 17th century Dutch East India Company (VOC). However, we have reinterpreted this concept in a modern way, creating a platform not for the pursuit of profit, but for the enrichment of human knowledge and cultural heritage.

3. the BGT ecosystem and how to participate

Ecosystem Composition

The BGT Coin is the innovative mechanism at the heart of this project. It is not just a virtual currency, but a digital token that represents a contribution to a historical discovery. The characteristics of the BGT Coin are as follows

Record and proof of donation: Each coin represents a donation to a specific project

Transparency: all transactions and usage are traceable on the blockchain

Community participation: Coin holders have the right to participate in project selection and evaluation

The entire process from donation aggregation to discovery and results sharing

5. progress report: periodic progress reports and sharing of interim results
6. verification of results: verification of final results by the evaluator
7. sharing of results: Validated results are shared with all participants and the global community

Community-driven decision-making process

 - Proof of expertise of the searcher (if required)

 - Project Participation

How BGT Coin Donations Work

BGT Coin is a digital token that represents a donation to a project. Its features are as follows

1. simplified acquisition: available for purchase on the BGT platform
2. flexible donation: small to large donations of any amount
3. project designation: Donations can be made to specific projects
4. transparency: all donation transactions are recorded and traceable on the blockchain

4. project management and transparency

Operated by a decentralized autonomous organization (DAO)

Project Proposal Process

4. initial review: a panel of BGT experts will evaluate the relevance and feasibility of the proposal.

Mechanisms for supporting activities through donations
